This enduring activity is designed to increase knowledge and change competency of medicolegal death investigation professionals and death certifiers' practices and strategies. This training is intended to improve the consistency and accuracy of disaster mortality data. Improved reporting will lead to improved disaster planning, response, and recovery at the local and national level and to enhanced data-driven public health messaging and interventions to prevent disaster-related deaths.

Prerequisites

Because this training covers a specific area of death investigation and certification (i.e., disasters), we are assuming that our primary audiences have a basic level of knowledge and skills on how to generally conduct death investigations and certifications. This training will build on that existing knowledge to expand on disaster-related deaths.

Additional Information

This training consists of three Modules: two core and one practice. After completing Modules 1 and 2, you will then choose a practice disaster scenario in Module 3. Click on the confirmation button at the end of the practice disaster scenario to complete the training.
