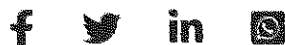

During his career, he was assigned to the patrol division and the investigative section as an evidence technician, as well as in informational services as a crime analyst. Frank Carson was assigned to the Crash Reconstruction Unit for 25 years, where he investigated several hundred fatal and critical injury crashes. He has testified in criminal and civil court numerous times in fatal crash cases and has been qualified as an expert witness by the courts on many occasions. Frank has taught and developed classes in Crash Reconstruction and Investigation for 20 years and taught DUI Detection and Testing to people throughout the country. He has consulted on crash fatality cases for local, state, and federal agencies and private companies. In addition to investigating fatal and critical injury crashes, Frank also performed traffic enforcement duties and commercial vehicle enforcement as a Department of Transportation Level I Commercial Vehicle Inspector. Frank has spoken at many community and agency groups and at NASA's Goddard Space Flight Center during traffic safety awareness training.

Nearly 40,000 people are killed in car crashes each year. In each of these crashes, there is evidence on the body in the form of injuries. It is important for investigators to understand vehicle crash dynamics and how impact and movement cause injury to the human body. Knowledge of the dynamics of these injuries and how they are inflicted will help the investigator come to conclusions about injury cause, seating position, and the crash type.

This course will walk you through understanding the basic physics of vehicle crashes and describe the five-vehicle crash classifications. The instructor then details various injuries on the body and how specific crash types can cause those injuries.

This course uses videos and photographs from crash investigations to demonstrate the classifications and injury types.
